<b><u>Corrupt &amp; Dishonest DII/Halliburton/HW Trust Fiduciary</u></b>	<b><u>Nature of Fraud</u></b>	<b><u>Additional Notes regarding Fiduciaries' Misconduct</u></b>
<b>Marcellene Malouf, Trust Executive Director</b>	Initiated 'sham' audit of Mandelbrot lasting 15 months. Conspired with other fiduciaries Steve Kazan/Al Brayton/Marla Eskin to 'blackball' Mandelbrot. Breached fiduciary duty to Claimant by suspending claim (2014) without due process. Lied to Mandelbrot/Claimant 2014-2015 regarding audits.	Wasted millions of dollars in Trust funds to benefit 'friends', conceal Trust fiduciary fraud, and harm Mandelbrot. A well-known liar. Completely ignorant to the DII/Halliburton liabilities. "Shopped" for attorneys to help conceal Trust Fraud. No due process. Wholly 'unfit' mentally to be working on any Trust. 'Stealing' a paycheck.
<b>Janet Jardin, Trust Counsel</b>	See above regarding Marcellene Malouf. Jardin was her 'partner in crime'. Purposefully delayed the audit of Mandelbrot/Claimant at least 6 months to further Trust's fraud. Knew the Trust was a 'sham' from the inception. Prepared fraudulent report displaying Mandelbrot in a 'false light' (see tab 18 in Blalock binder). When Mandelbrot responded the following day showing Jardin was a fraud, new Counsel was brought in.	The "Queen of lies and excuses". Completely ignorant to the DII/Halliburton Trust liabilities/alternate entities. After improperly suspending claimant, lied on multiple occasions regarding status of the audit. Conspired directly with Malouf to harm Claimant and Mandelbrot. Misappropriates Trust Funds through sham billings. After Jardin was caught committing fraud, Jardin attempted to 'cover it up' with a confidentiality agreement. Extortionist.
<b>Greg McHugh, Trust Counsel</b>	Conspired with Marcellene Malouf to further sham audit of Mandelbrot. Admitted no wrongdoing by Mandelbrot and then prepared a fraudulent report post audit in an effort to extort money from Mandelbrot. Ignorant to Trust's liabilities.	The definition of 'dishonesty'. Misappropriated hundreds of thousands in Trust funds to further audit of Mandelbrot. Once caught, hired another lawyer to further Trust fraud. Extortionist. No morals. Should be terminated. Doesn't understand the 'oath' of

		honesty. Should be disbarred and 'outed' as a fraud.
<b>Alan R. Brayton, DII/Halliburton Trust Advisory Committee Member</b>	Filed Fraudulent Trust claims (Kananian) concealed by the Trust to further Trust fraud. Has conspired with Steven Kazan (see below) to 'target' and 'blackball' Mandelbrot from multiple Trusts to help further fraud. Violates Department of Justice Rules by service as Fiduciary (and claim filer) on over 20 Trusts (the Department of Justice disfavors serving on more than <i>one</i> ). Kicked out of Ohio for Fraudulent bankruptcy claims.	Misappropriated at least \$500,000,000 from another Trust through fraudulent defaults (Western Asbestos). A known "Double Dipper." Mandelbrot's former employer where Mandelbrot first discovered and reported extensive Trust fraud. Helped initiate the audits of Mandelbrot (10+) after Mandelbrot alleged breach of fiduciary duty and fraud.
<b>Steven Kazan, DII/Halliburton Trust Advisory Committee Member</b>	See above. Brayton's 'partner in crime.' Violates Department of Justice Rules by service as Fiduciary (and claim filer) on over 20 Trusts (the Department of Justice disfavors serving on more than <i>one</i> ). Kicked out of Ohio for Fraudulent bankruptcy claims. Worked with Brayton to target Mandelbrot thus harming thousands and thousands of asbestos victims.	Misappropriated at least \$500,000,000 from another Trust through fraudulent defaults (Western Asbestos). A known "Double Dipper." Secretly pays off Doctors (Dr. Jablons) -(through sham donations) to get mesothelioma cases.
<b>Beverly Weiss Manne, Trust Counsel</b>	Conspired with above individuals to further the sham audit of Mandelbrot. An "interested party" who works directly with former Judge over the Trusts. Brought in to target Mandelbrot in October 2015 after McHugh's fraud. Extortionist. Attempted to extort over \$50,000 from Mandelbrot (had Mandelbrot paid, audit would have concluded). Through fraud, attempted to have Mandelbrot sign confidentiality agreement. Once Mandelbrot refused, kicked him out of the Trust claim filing system.	Breached oath as an attorney by attempting to further fraud. Knowingly acts with conflict of interest. Known violator of Department of Justice Rules. Dishonest to her core. Completely ignorant as to liabilities of Trust. Solely involved to further fraud and to misappropriate money from the Trust. Extremely unintelligent and deceptive. Purposefully lied to Claimants in order to make her 'billing requirements' for the year. A complete fraud.
<b>Mary Ellen Nickel, Director of DII/Halliburton Trust Claims</b>	A 'wolf' in Sheep's clothing. Specifically told Mandelbrot in 2014 that "we know you're not a bad guy ...and the audit should only a few weeks....". Knew this was lie. Conspired with Kazan/Brayton/Marla Eskin to harm Mandelbrot and Claimants.	Due to dishonesty, wholly unfit to serve on any Trust. Considered the 'worst' Trust Director in the Country due to ignorance, dishonesty and lack of good faith. Essentially just 'stealing' from the Trusts as her work is a sham.

<b>Nancy Freeman, Megan Gary, Michael Shiner, Trust Fiduciaries</b>	Participated in sham audit of Mandelbrot while conspiring with the above individuals.	Breached fiduciary duty to claimants. Misappropriated funds through fraud
<b>Marla Rosoff Eskin, Trust Counsel – Campbell &amp; Levine</b>	Former plaintiff's lawyer turned Trust Fiduciary (a criminal conflict of interest). Uses bias and conflicts to benefit certain attorneys (Kazan, Brayton) and harm others. Unquestionably guilty to Civil RICO, bad faith, collusion and fraud. A central 'link' to all Trust Fraud. Has misappropriated millions from Trust.	Not just an incredibly dishonest person (not a word she says is 'true'), but clearly unwise, imprudent, thoughtless, injudicious, irresponsible, and malicious in all Trust actions. A complete 'failure' as a plaintiff's lawyer who sought a 'gravy train' and a chance to misappropriate funds by working for Trusts.
